The Child Advocacy Center works to ensure that all of the children in Carroll County have access to a trained and qualified forensic interviewer who can help them through the criminal investigative process in a child friendly location and in a manner that doesn't further injure children who have been through traumatic events. The CAC and its multi-disciplinary team employ a nationally recognized and research-based protocol that is defensible in court and deemed "best practice for child abuse investigations" by the NH Attorney General. For abused children, the Center is place of hope and healing. As one mother who recently visited us said, "When my daughter and I arrived we felt scared and alone, but we left relieved, knowing that there is a team of people working to ensure that this will never happen to her or anyone else again."
